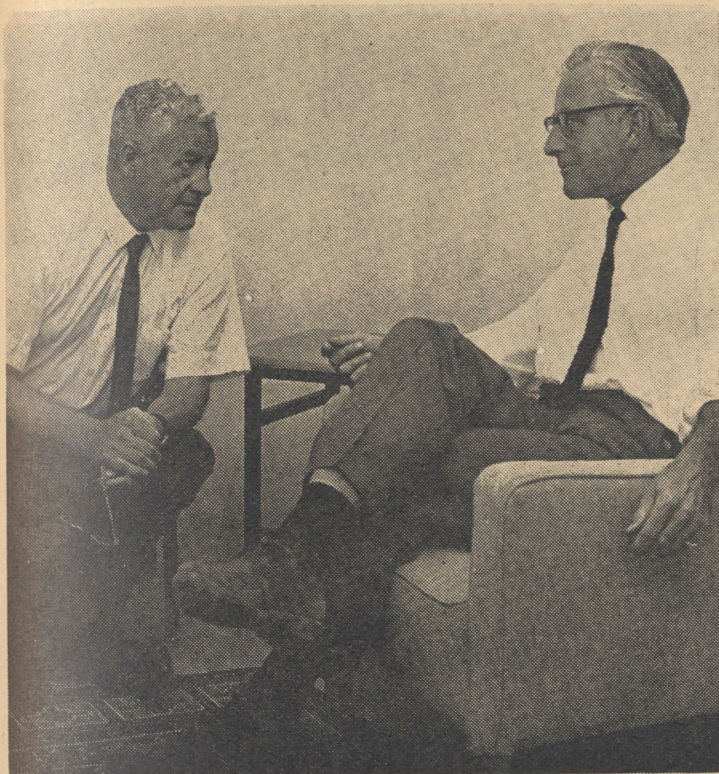

## ISRAEL, UAR TO CURB SUEZ MILITARY ACTIVITY

**GENERAL ODD BULL**, CHIEF UNITED NATIONS TRUCE SUPERVISOR IN THE MIDDLE EAST, has reported that Israel and the United Arab Republic have accepted

the call by him to stop all military activities in the Suez Canal, including the movement of boats, for the period of one month beginning 27 July. An exception was made to allow boats under the control of the Suez Canal Authority to provide supplies to ships stranded in the Canal.

The report, which has been submitted to the Security Council by the Secretary-General, also said that General Bull proposed to secure the services of additional observers to raise the total serving with the UN team in the Suez Canal area from 32 to 50. Twenty-six observers would be assigned to El Quantara Control Center on the east bank of the Canal, and 24 to Ismailia Control Center on the west bank.

A temporary agreement concerning the movement of boats in the Canal was reached in an effort to avoid incidents resulting from the differences in

## ISRAEL TO RETURN GOVT. HOUSE

**SECRETARY-GENERAL U THANT** HAS REPORTED TO THE SECURITY COUNCIL THAT ISRAEL HAS PROPOSED to return Government House and about one-third of the area included in its premises in Jerusalem, as headquarters for the Chief of the UN Truce Supervision Organization. He said that he was considering, as a first tentative step, authorizing the Chief and his staff to return immediately to that part of their headquarters now being offered, without prejudice to all rights and claims of the United Nations to occupancy and possession of the entire premises.

The report said that the Chief, General Odd Bull, has stated that he could operate in the reduced area provided that communications facilities outside the area offered for return would remain available to the Truce Supervision Organization and that unrestricted access to and adequate protection of these installations be ensured. It said that Israel had given this assurance and also the assurance that it would make no military use of the area not now being offered for return.

The report pointed out that General Odd Bull and his staff were labouring under the most serious handicaps due to lack of facilities normally available to them at Government House. It added that the situation might soon become even more critical as the Truce Supervision Organization must vacate its temporary offices in the YMCA, since that institution has been pressing the need on the space.

## WORLD NEEDS MORE DENTISTS

**DENTISTS ARE A RARE BREED:** there are only 432,237 of them in the whole world — or one dentist for every 5,600 people.

According to the **World Directory of Dental Schools** just published by the World Health Organization, the most serious shortage of dental professionals is found in Africa where the rate is one dentist for every 81,000 inhabitants.

The number of dental schools has risen from 320 in 1958 to 371 in 1963 when 15,300 new dentists graduated.

## BRITCON OFFICER KILLED IN ROAD ACCIDENT

**A** N OFFICER OF THE 5TH ROYAL INNISKILLING DRAGOON GUARDS SERVING WITH UNFICYP WAS KILLED IN A ROAD ACCIDENT LAST SUNDAY MORNING.

The officer, 2/Lt A.C.N. Mitchell, 21, of DrumPark, By Dumfries, Scotland, was riding in command of a Ferret Scout Car when the vehicle overturned near Pissouri — on the road from Limassol to Ktima — as it tried to avoid an oncoming civilian car. The Ferret turned over three times after it left the road. The driver escaped injury.

The body of Lt Mitchell has been taken to the Royal Air Force Hospital at Akrotiri and will be flown back to the United Kingdom for burial.

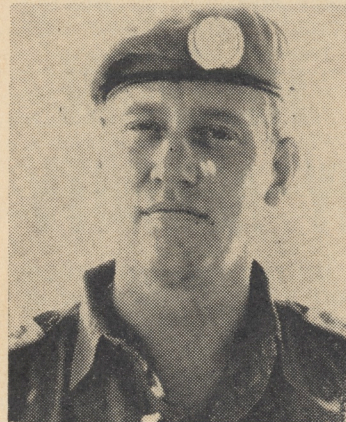
Lt Mitchell arrived in Cyprus with the 5th Inniskilling Dragoon on the last day of 1966 when he began his UNFICYP service.

The accident took place close to the spot where another Scout Car — a Panhard which belonged to the 4 Infantry Group of the UNFICYP Irish Contingent — also went off the road in April 1965. In that accident an Irish sergeant was killed and a private Irish soldier was injured.

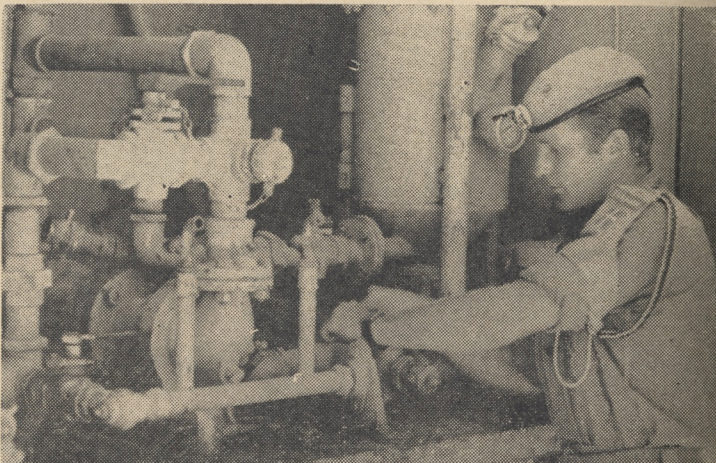

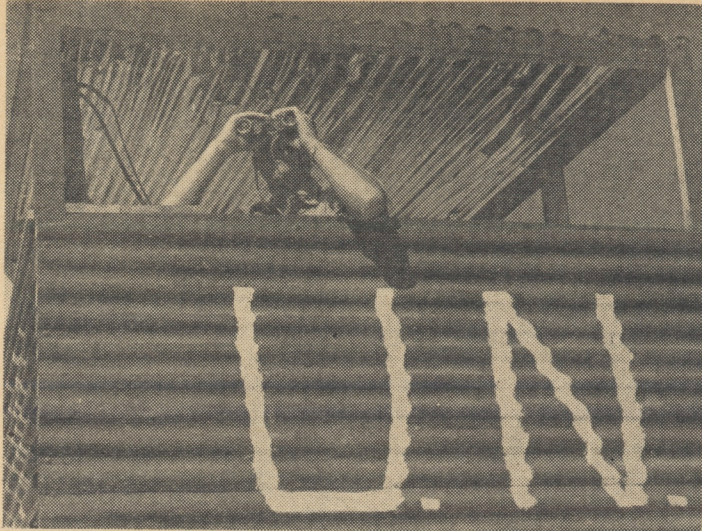

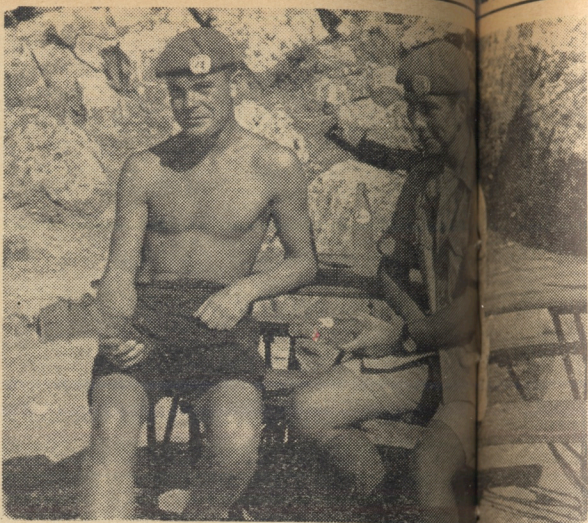
“ODDMAN OUT”

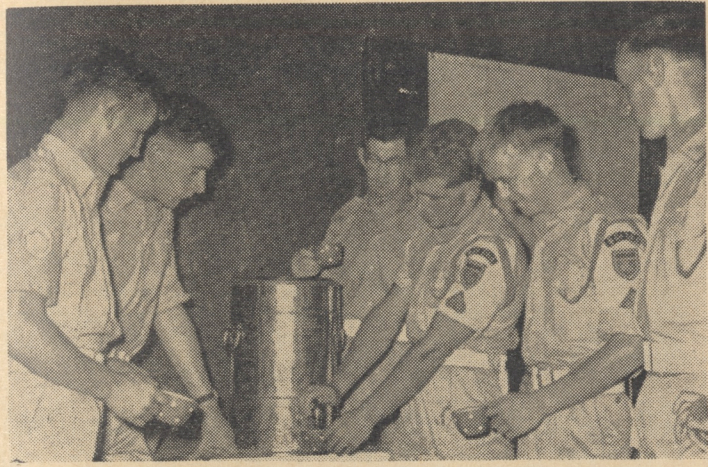
SCHOLARSHIP FOR 8TH INF GROUP OFFICER

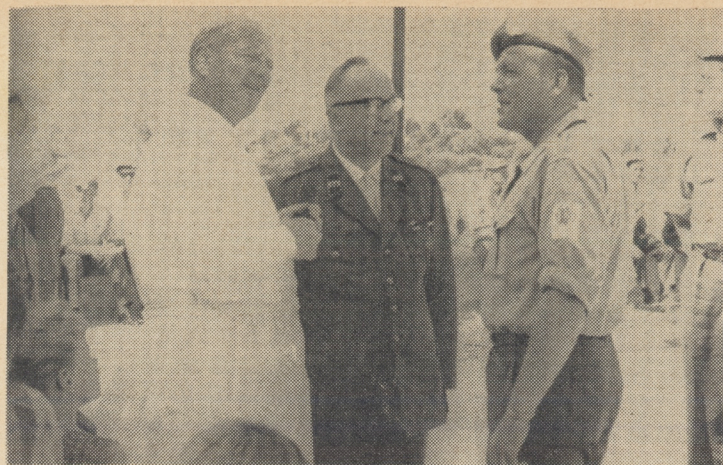

## UN TENTS FOR TURKISH QUAKE VICTIMS

**THE DEATH AND DESTRUCTION IN TURKEY WHICH RESULTED FROM THE RECENT EARTHQUAKES** brought offers of aid to that country from the United Nations.

Secretary - General U Thant approved the expenditure of \$20,000 to buy some 300 tents for the victims. Turkey had informed the Secretary-General that there was an urgent need for some kind of temporary dwellings for those left homeless by earthquakes.

## SEMINAR URGES ANTI-COLONIAL DECLARATION

**VARIOUS RECOMMENDATIONS AND CONCLUSIONS ABOUT APARTHEID, RACIAL DISCRIMINATION AND COLONIALISM** in southern Africa were approved by a UN seminar as it concluded its two-week session in Kitwe, Zambia.

The seminar considered that continued existence of racial discrimination and colonialism in that part of the world was a crime against humanity and threatened peace and security. The UN and its members were urged to take effective measures to eradicate it.

The seminar recommended to the General Assembly to adopt a Declaration, recognizing the legitimacy of the struggle of the people of South Africa, South West Africa, Southern Rhodesia and the territories under Portuguese administration to achieve their freedom and independence.

## JORDAN PROTESTS ARREST OF JERUSALEM ARABS

**IN A LETTER TO THE PRESIDENT OF THE SECURITY COUNCIL**, Jordan protested against Israel's acts of arrest, detention and exile as constituting a clear defiance

the positions of the UAR and Israel regarding the presence of boats in the Canal. Israel maintained that either boats of both parties be allowed to move freely on the appropriate side of the Canal, or that no boats be permitted there.

Israel also expressed its intention of placing boats in the Canal. The UAR stated that the best way to avoid any violation of the cease-fire was for parties to desist from seeking to change the situation which prevailed on 10 July, when a consensus was reached in the Security Council. The UAR maintained that there had been Egyptian boats in the Canal at that time, but not Israeli boats. It stated that it would regard the placing of Israeli boats in the Canal as a violation of the cease-fire to which the UAR would feel obliged to reply by firing on the boats.

The situation was complicated by the presence in Bitter Lakes of ships which had been stranded there since the beginning of hostilities on 5 June when the Canal was closed. An agreement was reached on the understanding that it was to be considered strictly from the point of view of maintaining the cease-fire without prejudice to the political or legal issues involved.

ce of the UN resolutions calling upon her to ensure the safety, welfare and security of Arab inhabitants of the occupied areas.

The letter referred in particular to the case of the Jordanian Governor of the Old City of Jerusalem and three other prominent Arab leaders who were detained and later banished from Jerusalem. They were banished, it said, for asking their people to resist what the UN had rejected and declared invalid Israeli actions to annex the Old City.

In another letter, Jordan charged that Israel had tortured and murdered the west bank citizens in an effort to deter the refugees on the east bank from returning to their homes.

## UN TO VIEW UNION RIGHTS IN S. AFRICA

**THE SPECIAL WORKING GROUP OF EXPERTS SET UP BY THE UN COMMISSION ON HUMAN RIGHTS** to investigate the treatment of prisoners in South Africa has made plans to take up further the task recently given to it by the Economic and Social Council, i.e., to consider the allegations regarding the infringement of trade union rights in South Africa.

These allegations concern in particular the prohibition of strikes, imprisonment of African workers who participated in them and detention in solitary confinement of certain trade union leaders.

## UN SW AFRICA COUNCIL OPENS WORK MEETINGS

**THE UNITED NATIONS COUNCIL FOR SOUTH WEST AFRICA HELD ITS FIRST MEETING** last week at UN Headquarters in New York and agreed to rotate its presidency among its 11 members.

The Council was set up under a resolution of the General Assembly calling for UN takeover of the administration of South West Africa with a view to helping it to secure speedy independence. This followed last year's decision by the Assembly to terminate South Africa's League of Nations mandate in the territory.

South Africa, which regards the decision as illegal, has said that she would resist the UN takeover.

In establishing the Council last May, the Assembly requested it to enter into immediate contact with the authorities of South Africa to arrange for the transfer of the administration of South West Africa

"with the least possible upheaval". South Africa was asked to facilitate the transfer without delay, and the Security Council was requested to take all appropriate measures to enable the UN administering body to carry out its responsibilities.

Opening the first meeting of the Council for South West Africa on Thursday, 10 August 1967, Secretary-General U Thant said that its work offered a new possibility of reconciliation and a chance to stem the growing racial hostility in southern Africa. He expressed the hope that all Member States would cooperate fully to give effect to the decision to make South West Africa a direct UN responsibility.

The Council will consider the organization of its work at another meeting to be called, following consultations among its members who are: Chile, Colombia, Guyana, India, Indonesia, Nigeria, Pakistan, Turkey, the United Arab Republic, Yugoslavia and Zambia.

## INDONESIA TO ACT ON WEST IRIAN PLEBISCITE

**IT WAS MADE KNOWN AT UN HEADQUARTERS IN NEW YORK ON 8 AUGUST 1967 THAT UN UNDER-SECRETARY JOSE ROLZ-BENNETT** has just completed successful talks with the Indonesian Government on the remaining responsibility of the world Organization under the 1962 agreement on West Irian.

Under the agreement, authority over the territory was transferred from the Netherlands to the United Nations for a transitional seven-month period, and then turned over to Indonesia on 1 May 1963. The agreement provided for an act of free choice as to their future to be carried out by the people of West Irian before the end of 1969, with a UN representative going there a year in advance to participate in the arrangements.

In the course of recent talks with UN Under-Secretary Rolz-Bennett, the Indonesian Government reaffirmed the intention of carrying out its responsibility under the agreement, and a UN representative will be appointed and sent to West Irian in 1968.
