DESCRIPTION OF REQUIREMENTS

REQUEST FOR EXPRESSION OF INTEREST

1. The United Nations Organization Stabilization Mission in the Democratic Republic of the Congo (MONUSCO), seeks Expression of Interest (EOI) from duly registered companies for Rental of Heavy Civil Equipment for various projects (ground works) and maintenance at the Kananga Airport, DR Congo.
2. MONUSCO will undertake a competitive bidding exercise shortly and accordingly intends to issue an Invitation to Bid (RFQ) to those companies who would express their interest and provide initial relevant information demonstrating their ability to fulfill MONUSCO requirements. In addition, the interested companies will be requested to complete UN Vendor registration for level 1 on the vendor database accessible on ungm.org (new vendor only). A detail Scope of Requirement (SOR) will be provided to companies short listed for receipt of the (RFQ) documents.
3. The EOI should specify brief relevant information about the company including the company's profile, capacity/capability and experience. Vendors will be shortlisted based on their ability to provide the relevant documents showing that they are authorized to undertake business in DRC. Interested vendors must provide the following documents with their response.
 - Copy of the registration certificate/license (s) of the company.
4. Please note that this request for EOI is not an invitation for submission of bid.

SPECIFIC REQUIREMENTS / INFORMATION (IF ANY)

The aim of the Provision of Rental of Heavy Civil Equipment is due to the degradation of the Runway. In that regards, Aviation Section have raised concerns about safety and security and their requirements is as follow:

- Clearing, levelling, compacting of the area along the runway and resurfacing if required.
- Clearing, leveling and compacting the identified areas where 10 tentes will be erected.
- Clearing, leveling and compacting of 250 m taxiway to the hangar.
- Compacting of the ground inside the hangar.
- Clearing, leveling and compacting of parking of 2 helicopters.

1 . La Mission de l'Organisation des Nations Unies pour la Stabilisation en République Démocratique du Congo (MONUSCO) sollicite des manifestations d'intérêt pour la location des engins lourds pour divers projets (travaux de sol) et entretien pour l'Aéroport de Kananga, RD Congo.

2. MONUSCO entreprendra un exercice d'appel d'offres et établira un document de sollicitation aux sociétés qui auront exprimé leur intérêt et auront fourni des informations pertinentes initiales démontrant leur capacité à satisfaire les exigences de la MONUSCO. En outre, on demandera aux sociétés intéressées de remplir le formulaire d'enregistrement des fournisseurs (seulement pour les nouveaux fournisseurs) dans le site ungm.org, www.ungm.org. Les spécifications détaillées seront fournies aux

sociétés présélectionnées pour la réception des documents de sollicitation.

- Entretien, nivellement et compactage des aires de stationnement de 2 hélicoptères.
