REQUEST FOR EXPRESSION OF INTEREST

1. The United Nations Organization Stabilization Mission in the Democratic Republic of the Congo ("MONUSCO), seeks Expressions of Interest (EOI) from duly registered and licensed companies for the Provision of crushed stone dust in MONUSCO, Kinshasa, Democratic Republic of Congo.

2. MONUSCO will undertake a competitive bidding exercise shortly and accordingly intends to issue a Intersest to Invitation to Bid (ITB) to those companies who would express their interest and provide initial relevant information demonstrating their ability to fulfill MONUSCO requirements. In addition, the interested companies will be requested to complete UN Vendor registration for level 1 on the vendor database accessible on ungm.org (new vendors only). A detailed Scope of Work (SOW) will be provided to companies short listed for receipt of the ITB documents.

3. The EOI should specify brief relevant information about the company including the company's profile, capacity/capability and experience to provide Airfield lighting system components .

4. Please note that this request for EOI is not an invitation for submission of a bid.

5. MONUSCO reserves the right in selecting the invitees for the competitive bidding based on substantial and proven records of performance in the subject field of activities and were submission of an EOI would not automatically warrant receipt of the ITB documents.
