The United Nations Organization Stabilization Mission in the Democratic Republic of the Congo ("MONUSCO"), seeks Expressions of Interest (EOI) from duly registered and licensed companies for the PROVISION OF GROUND POWER UNITS for Heavy and Medium Aircrafts for MONUSCO in Democratic Republic of Congo .

MONUSCO will undertake a competitive bidding exercise shortly and accordingly intends to issue an Invitation to Bid (ITB) to those companies who would express their interest with the shortest possible delivery period and provide initial relevant information demonstrating their ability to fulfill MONUSCO requirements. In addition, the interested companies will be requested to complete UN Vendor registration for level 2 on the vendor database accessible on ungm.org (new vendors only). A detailed Scope of Work (SOW) will be provided to companies short listed for receipt of the ITB documents.
3. The EOI should specify brief relevant information about the company including the company's profile, capacity/capability and experience. Vendors will be shortlisted based on their ability to provide the relevant documents showing that they are authorized to operate Aviation services in DRC. Interested vendors must provide the following documents with their response:
 - Copy of the registration certificate / license(s) of the company
 - Valide permit to operate in Civil Aviation Services. In case you provide expired permit can reference us to reject your EOI.
