REQUEST FOR EXPRESSION OF INTEREST

The United Nations Organization Stabilization Mission in the Democratic Republic of the Congo ("MONUSCO"), seeks Expressions of Interest (EOI) from duly registered and licensed companies for the Provision of Construction Services for Toilets and Showers, Septic Tanks, Soak Pits and Grease Traps in North Kivu Region, D.R. Congo

MONUSCO will undertake a competitive bidding exercise shortly and accordingly intends to issue a Request for Proposal those companies who would express their interest and provide initial relevant information demonstrating their ability to fulfill MONUSCO requirements. In addition, the interested companies will be requested to complete UN Vendor registration for Level 2 on the vendor database accessible on ungm.org (new vendors only).
3. The EOI should specify brief relevant information about the company including the company's profile, capacity/capability and experience. Vendors will be shortlisted based on their ability to provide the relevant documents showing that they are authorized to undertake business in DRC. Interested vendors must provide the following documents with their response:
